On 09-23-11 at approximately 1100 hours, I created a photo line up, which included 6 MVD photos, with the suspect, Kristopher Michael Lauchner at position #5.

On 9/27/11 at abut 1112 hours, I responded, with Officer Ange, to in an attempt to contact Kristopher Lauchner, regarding a counterfeit currency case.

Upon arrival, after knocking on the apartment door, we received no answer. Then, while preparing to leave, a white male passed us in the lot (in a car) and asked if we were looking for him. He said his name was Kristopher Lauchner. I told him that we indeed wished to speak with him.

Lauchner parked his car and then escorted us to his apartment. He opened the door. I asked him if we could step inside. He allowed us to enter.

Once inside, Lauchner spoke to Officer Ange about a counterfeit money case that she was working on. Lauchner claimed to have originally received the fake \$100 form a guy, "Jose" that he met at a pool hall. He said that he sold his pool cue to the guy for \$300. Once he learned that the money was fake, he found the guy again (the same night that he tried to pass the \$100 bill at Fascinations) again at the pool hall. He gave the guy back the remaining 2 bills and took his cue back. See Officer Ange supplement for further regarding the interview.

During the interview, I asked Lauchner if he had any more counterfeit money in the apartment. He said that he did not. After establishing that he shared a bedroom with his fiance Desiree Capuano (Lauchner pointed out his bedroom), I asked him if I could search his bedroom for counterfiet money. He said that I could but he did not know if Desiree would give permission. I again asked if I could search the bedroom. He stated, "absolutely".

I searched the bedroom that Lauchner claimed to share with Desiree. I discovered the following:

- 1. Large green bong located in the master bath vanity
- 2. Brown box located in the night-stand to the right of the bed. In the box were two glass pipes with residue and two stone pipes. Also in the box was a small baggy containing a green leafy substance. The green leafy substance had the color, odor, an consistency of marijuana.

I showed Lauchner the items. I read him his rights under Miranda. he said that he understood. I asked him who the items belonged to. He would not answer. Just then, Desiree, entered the apartment. I showed her the items, she said that they were hers. I read Desiree her rights under Miranda. She said that she understood her rights. I again asked Desiree if the items, including the marijuana and pipes, were hers. She stated that items were indeed hers. She stated that she plans on getting a medical card for the future use. She stated that this was the only illegal thing that she did.
