On 10/1/11 at 1015 hours, I met with Loss Prevention Manager Rebecca Parker at Walmart, 15355 N. Northsight.

Rebecca wanted to report a fraudulent return. She stated the following:

Rebecca stated that on 11/1/11, suspect Kristopher Lauchner was arrested for passing counterfeit currency at the store related to incidents on 10/29, 10/30, and 11/1/11. She reviewed the store video and noticed that Lauchner made a return at her store on 11/1/1, prior to making the fraudulent purchase on that date. Rebecca provided documentation to show that Lauchner returned an item that he purchased on 10/30/11 with the counterfeit bills that he was subsequently arrested for.

Rebecca provided a return receipt that showed that two items were returned by Lauchner. The following items were returned:

- 1. An airgun that had been purchased for \$148, on 10/29/11 from another Walmart (store 5330) Refund including tax of \$161.76
- 2. WIFI Blueray that had been purchased for \$108, on 10/30/11 at Rebecca's store (store 2766) Refund including tax of \$117.67

Per Rebecca, the receipt used to return the Blueray was the same receipt number (TC# 0633 0022 9387 7087 7818 8) from the purchase on 10/30/11. It was the same receipt from the sale captured on video of Lauchner on 10/30/11. The original transaction was cash. A \$100 bill and a \$50 bill were used. A \$100 and a \$50 were found to be counterfeit that day. The bills were turned over to PD. See DR # 11-25802.

Lauchner left the store (the day he was arrested on 11/1/11) with \$117.67 (proceeds from the fraudulent return).

Since the airgun had been purchased at a different Walmart, it is yet unknown if it was purchased with counterfeit bills.

Rebecca provided the video related to the purchase and the return of the Blueray, at her store.

Lauchner will be long formed for the following charge related to the theft of \$117.67, assuming he is not arrested prior to the submission.

Please see related DRs regarding Lauchner passing counterfeit U.S. Currency:

11-21751 - passed a counterfeit \$100 bill at Fascinations.

11-25802 - passed counterfeit bills at Walmart on 10/29/11, and 10/30/11, 11/1/11.

On 11/15/11, I spoke to Kristopher Lauchner , via the telephone. I told him that I would like him to come in so I could interview him. He said, "Not if your going to arrest me." I explained that I was going to be submitting new charges related to the Fascinations case, and for the fraudulent return at Walmart. He said that he could explain all that. I told him that I did not believe him and that he already lied when he told the arresting officers that he got the money from "Jose" at the pool hall and could not find

said that he lied about that. I told Lauchner that I was interested in finding out where he was getting the fake money. He said, "He is in jail." Lauchner said that maybe he needed to speak to his lawyer. I told him that he needed to weigh his options. Lauchner said that he would call me back. It should be noted that Rebecca gave me three counterfiet \$20 bills that were passed in the store on 11/1/11, the day that Lauchner was arrested after purchasing ink with counterfeit U.S currency at her Store. She was unable to determine who passed the three counterfeit \$20 bills. The bills are obviously counterfeit as they all have the same serial number of: I impounded the three counterfeit \$20 bills and D4. I impounded the related video at D4. Rebecca will assist with prosecution on behalf of Walmart.
