Topic: ORIGINAL NARRATIVE

Synopsis:

On 12-13-11 at about 1742 hours, Kristopher Lauchner, committed shoplifting by walking out of Kohl's located at 9220 W. Northern Avenue Peoria, AZ 85345 with unpaid items valued at \$446.98 dollars.

Narrative:

On 12-13-11 at about 1734 hours, I was dispatched to Kohl's located at 9220 W. Northern Avenue for a shoplifting in progress. I was advised by Peoria Police Dispatch, a white male had ripped off price tags, he had a cart full of merchandise, and was now by the front doors of Kohl's on his cell phone.

On arrival I waited by the east side of Kohl's. About a minute later I was advised the suspect left Kohl's with the cart and was now running through the parking lot.

I drove up on scene and saw loss prevention, Andres Chavez, pointing at a white male by a black Infinity SUV, with AZ license plate 665-REK. The driver side door was open and the vehicle was backed into the first parking space closest to Kohls. I later identified the suspect as Kristopher Lauchner with an Arizona driver's license.

I contacted Kristopher by his vehicle and detained him by placing him in double locked handcuffs behind his back. Officer Acevedo contacted lost prevention and was advised Kristopher had made it past all points of purchase and outside of Kohls without paying for the items. Once lost prevention went outside to confront Kristopher, he ran leaving the cart full of merchandise out front of the store.

I advised Kristopher he was under arrest and he was brought into the lost prevention office in Kohls.

Inside the cart Kristopher took was a mini pool table, jacket, throw blanket, shirt, pants and a back pack. The total value of these items was \$446.98

At about 1801 hours, I read Kristopher his Miranda Rights from a department issued Miranda Rights card. Kristopher stated he understood his rights by saying "yes sir."

Kristopher told me he was Christmas shopping, he was tired, and he did not mean to walk out of the store with the unpaid merchandise. He told me his wife, Desiree Capuano, was supposed to meet him at Kohl's to help him shop but she forgot to meet him. He advised me he walked out of the store, he heard the alarm go off, and saw two subjects running after him, so he ran.

I was advised by loss prevention earlier they had seen Kristopher tear a price tag off of a jacket and hide the tag. I asked Kristopher about the price tag taken off of the jacket and he told me he did not remember doing this. Loss prevention advised me this was caught on video surveillance.

I asked Kristopher if I could get Desiree's phone number out of his phone to confirm his story. He stated I could. I called Desiree and asked her if she knew where Kristopher was at. She told me she did not know and he was supposed to be home for dinner. I asked her if she was supposed to meet him anywhere today and she told me she was not and she had no idea where he was at. She advised me the last time she spoke with Kristopher was about 45 minutes prior.

I read Andres store report which states Kristopher put items into his shopping cart and walked toward the front doors of the store where he paced back and forth while on his cell phone looking outside. Loss prevention kept continuous watch on Kristopher and watched him walk out of the store with the cart full of merchandise past all points of purchase. Andres states him and Sergio Camacho, the other loss prevention officer, approached Kristopher and verbally identified themselves as loss prevention and with identification. Kristopher ran from loss prevention and Sergio followed Kristopher asking him to come back into the store but Kristopher did not comply. Andres stated he stood by the cart out front and police arrived on scene taking Kristopher into custody.

Andres advised me Kohls was willing to aid in prosecution and he was given a copy of the victims rights form.

Kristopher was trespassed from Kohls and issued his copy of the citation for shoplifting. He was given a court date of 01-10-12 at the Peoria City Court.

The video surveillance disk was impounded as evidence at the Peoria Police Station.

This case is cleared by arrest.
