#### THEFT OF FIREARM

ON 9/26/12 AT 1652 HOURS I RESPONDED TO CABELA'S LOCATED AT 9380 W GLENDALE AVE REFERENCE A CALL OF A THEFT OF A FIREARM THAT HAD OCCURRED THE PREVIOUS DAY. UPON MY ARRIVAL I CONTACTED (VR1) RONALD BEYE WHO ADVISED THAT ON 9/25/12 AT APPROXIMATELY 1700 HOURS A MALE SUSPECT HAD COMMITTED THEFT BY REMOVING AN AR15 ASSAULT RIFLE FROM THE CABELA'S AFTER HAVING CONCEALED IT AND OTHER MERCHANDISE WHICH HE PURCHASED.

RONALD STATED THAT AT APPROXIMATELY 2300 HOURS ON 9/25/12 CLEANING STAFF FOR THE CABELA'S HAD BEEN CLEANING THE MALE RESTROOM WHEN THEY LOCATED A MERCHANDISE TAG FOR AN AR15 ASSAULT RIFLE THAT HAD BEEN TUCKED INTO THE SEAT PROTECTION NAPKIN BIN ABOVE ONE OF THE

TOILETS IN THE MALE RESTROOM. WHEN THE CLEANING STAFF LOCATED THE MERCHANDISE TAG THEY IMMEDIATELY NOTIFIED A MANAGER WHO IN TURN NOTIFIED RONALD. RONALD STATED THAT HE BEGAN AN INVESTIGATION INTO THE MERCHANDISE TAG AND DETERMINED THAT A FIREARM WAS MISSING. RONALD STATED THAT THE FIREARM WAS A BLACK IN COLOR BUSHMASTER AR15 ASSAULT RIFLE WHICH IS A .223 CALIBER RIFLE THAT CAME WITH A RED DOT BUSHMASTER SCOPE MOUNTED ON IT AND A 30-ROUND MAGAZINE. THE RIFLE WAS WORTH \$679.99 AND THE SERIAL NUMBER FOR THE RIFLE IS RONALD SAID THEY IMMEDIATELY STARTED MAKING CONTACTS WITH THEIR CORPORATE LOSS PREVENTION PERSONNEL AS WELL AS THEIR ATF CONTACT PERSON FOR THE STORE TO MAKE NOTIFICATION THAT THE FIREARM WAS MISSING.

RONALD ADVISED THAT ASSET PROTECTION EMPLOYEES CHECKED THE FIREARMS AREA OF THE STORE WHERE THE RIFLE WOULD HAVE BEEN ON DISPLAY FOR SALE AND THEY LOCATED A TRIGGER LOCK THAT HAD BEEN PRIED OPEN AND DISCARDED ON ONE OF THE FIREARM DISPLAY SHELVES WHICH HE ADVISED ALSO CONTAINED AN ELECTRONIC THEFT DETECTION DEVICE THAT WOULD HAVE SET OFF THE DOOR ALARMS HAD THE RIFLE BEEN REMOVED FROM THE STORE WITH THE LOCK STILL ON IT.

RONALD STATED THAT HE BEGAN WORKING ON REVIEWING ALL THE VIDEO SURVEILLANCE FOR THE STORE FOR 9/25/12 WITH HIS ASSET PROTECTION TEAM, AFTER HE HAD BEEN NOTIFIED BY STORE MANAGEMENT WHEN THE CLEANING EMPLOYEES HAD LOCATED THE MERCHANDISE TAG IN THE MENS RESTROOM. RONALD ADVISED THAT HIS ASSET PROTECTION TEAM CONTINUED SORTING THRU VIDEO SURVEILLANCE TODAY, 9/26/12, AS THEY TRIED TO PIECE TOGETHER HOW THE FIREARM WENT MISSING AND WHO COULD HAVE TAKEN THE FIREARM.

RONALD ADVISED THAT AFTER GOING THRU HOURS OF VIDEO SURVEILLANCE THEY LOCATED THE SUSPECT WHO IS DESCRIBED AS A WHITE MALE, CLOSE TO 6' TALL, OVER 200 LBS, WITH BROWN HAIR, WEARING KHAKI IN COLOR CARGO OR TACTICAL STYLE PANTS AND A BLUE PLAID BUTTON UP SHIRT WHICH WAS UNBUTTONED BEING WORN OVER A WHITE T-SHIRT. THE SUSPECT COULD BE SEEN ENTERING THE FIREARMS SECTION OF THE STORE WHERE HE SELECTED THE MISSING ASSAULT RIFLE WHICH HE THEN PLACED IN A SHOPPING CART. THE SUSPECT THEN PROCEEDED OVER TO THE CAMPING SECTION WHERE HE SELECTED A FOLD-UP CAMPING COT IN A CANVASS CARRY BAG AND AFTER PLACING THAT ITEM IN HIS CART THE SUSPECT PROCEEDED TO THE BACK OF THE STORE WHICH IS THE EASTERN END OF THE STORE IN AN AREA WHERE IT IS TOUGH TO DETERMINE WHAT THE SUSPECT IS DOING. RONALD ADVISED THAT IT APPEARED THAT THE SUSPECT PLACED THE RIFLE INTO THE CANVASS BAG WHICH CONTAINED THE FOLD-UP COT AND HE THEN PROCEEDED TO THE CASH REGISTER AREA WHERE HE PURCHASED THE FOLDING COT, USING A CREDIT CARD. AFTER COMPLETING THE PURCHASE OF THE

COT THE SUSPECT THEN PROCEEDED TO THE MENS RESTROOM WHERE THE CLEANING CREW HAD LOCATED THE MERCHANDISE TAG FOR THE FIREARM AND THE SUSPECT REMAINED IN THIS RESTROOM FOR APPROXIMATELY FOUR MINUTES. THE SUSPECT THEN EXITED THE RESTROOM AND WALKED OUT OF THE STORE AND THEN TURNED SOUTHBOUND AND WALKED OUT OF THE VIDEO SURVEILLANCE SYSTEM'S VIEW AND IT COULD NOT BE DETERMINED IF HE ENTERED A VEHICLE.

RONALD STATED THAT BASED ON THE PURCHASE THE SUSPECT MADE THEY ARE ABLE TO PERFORM A RECORDS CHECK OF THE CREDIT CARD TRANSACTIONS AND THEY LOCATED THE SUSPECT'S NAME, (S1) KRISTOPHER LAUCHNER, WITH A MIDDLE INITIAL M. RONALD SUPPLIED ME WITH A COPY OF THE CREDIT CARD PURCHASES FOR KRISTOPHER WHICH SHOWED AN ACCOUNT NUMBER OF 4750560000018390 SHOWING THAT KRISTOPHER HAD A TOTAL OF SIX TRANSACTIONS WITH THIS CREDIT CARD DATING BACK TO 5/14/12 AND CULMINATING HIS PURCHASE ON 9/25/12 OF THE FOLD-UP COT FOR \$44.07. THE TRANSACTION REPORT DID NOT CONTAIN ANY OTHER IDENTIFYING INFORMATION FOR KRISTOPHER AND AT THAT TIME I BEGAN TO PERFORM RECORD CHECKS ON KRISTOPHER'S NAME IN ORDER TO FULLY IDENTIFY HIM.

AFTER PERFORMING SEVERAL RECORD CHECKS IN THE ARIZONA MOTOR VEHICLE DIVISION, I WAS ABLE TO LOCATE KRISTOPHER'S INFORMATION AND AT THE SAME TIME THE ASSET PROTECTION TEAM HAD PERFORMED A RECORDS CHECK ON HIS NAME TO THE ARIZONA DEPARTMENT OF CORRECTIONS WEBSITE AND LOCATED A RECORDS FOR THE SAME SUBJECT I HAD LOCATED IN THE ARIZONA MOTOR VEHICLE DIVISION, ALONG WITH A MATCHING PHOTOGRAPH WHICH APPEARED TO BE THE IDENTICAL PERSON AS THE SUSPECT RONALD HAD SHOWED ME IN THE VIDEO SURVEILLANCE. RONALD WAS ABLE TO GET A CLEAR SHOT IN ONE OF THE ELEVATORS WHEN THE SUSPECT LOOKED UP DIRECTLY INTO THE CAMERA. THE FACE OF THE SUSPECT APPEARED TO BE IDENTICAL TO KRISTOPHER'S DEPARTMENT OF CORRECTIONS PHOTOGRAPH FROM THEIR WEBSITE.

I CONTACTED COMMUNICATIONS AND COMMUNICATIONS SPECIALIST #10850 ENTERED THE STOLEN ASSAULT RIFLE INTO NCIC/ACIC WITH A NIC

I CONTACTED A SUPERVISOR AND NOTIFIED THEM OF MY INVESTIGATION AND THEY IN TURN CONTACTED THE ON-CALL INVESTIGATIONS SUPERVISOR AND SUPPLIED THEM WITH THE INFORMATION.

RONALD ADVISED THAT CABELA'S DID DESIRE PROSECUTION IN THIS MATTER AND I SUPPLIED THEM WITH A VICTIM RIGHTS FORM.

RONALD SUPPLIED ME WITH MULTIPLE PRINTOUTS, INCLUDING HIS ASSET PROTECTION REPORT, A DETAILED HISTORY OF KRISTOPHER'S PURCHASES AT

COPIES OF ALL THESE REPORTS WILL BE INCLUDED WITH THIS REPORT AS SUPPORTING DOCUMENTS. IT SHOULD BE NOTED THE RONALD DID STATE THAT BOTH THE MERCHANDISE AND THE TRIGGER LOCK HAVE BEEN HANDLED BY SEVERAL EMPLOYEES EACH BEFORE HE HAD SUPPLIED ME WITH THEM.

RONALD ALSO SUPPLIED ME WITH A TOTAL OF SIX DISKS WITH THE VIDEO SURVEILLANCE RECORDED ON THEM IN CHRONOLOGICAL ORDER DETAILING THE ENTIRE SERIES OF EVENTS FOR THIS INVESTIGATION. ALL THE DISKS WERE LATER LOGGED INTO PROPERTY AS EVIDENCE.

I LATER MET WITH DETECTIVES AND SUPPLIED THEM WITH ALL THE INFORMATION FOR THIS INVESTIGATION, AND AT THE TIME OF THIS WRITING FOLLOW-UP INVESTIGATION IS BEING CONDUCTED AND ATTEMPTS ARE BEING MADE TO LOCATE KRISTOPHER.

THIS CONCLUDES MY INVOLVEMENT IN THIS MATTER.

#### **NARRATIVE**

I AM AN INVESTIGATOR ASSIGNED TO A SQUAD OF DETECTIVES WITH A PRIMARY OBJECTIVE OF IDENTIFYING, INVESTIGATING, AND APPREHENDING REPEAT CRIMINAL OFFENDERS. I DRESS IN PLAIN CLOTHES AND DRIVE AN UNMARKED POLICE VEHICLE. SURVEILLANCE IS A MAJOR PART OF MY JOB ASSIGNMENT. I HAVE RECEIVED TRAINING IN UNDERCOVER OPERATIONS.

AT AROUND 1345 HRS ON TUESDAY, 10/02/12 I TOOK UP A POSITION TO WATCH A RESIDENCE IN PEORIA LOCATED AT DR. I RELIEVED DET. LOWE. IHEARD DET. LOWE REPORT EARLIER THAT HE HAD OBSERVED SI KRISTOPHER LAUCHNER AT THIS LOCATION. I HAD LEARNED FROM DET. ZYGMONT THAT PROBABLE CAUSE EXISTED FOR KRISTOPHER'S ARREST. DET. ZYGMONT HAD INFORMED ME THAT THERE WAS EVIDENCE THAT KRISTOPHER HAD STOLEN FROM THE CABELA'S A PRE-OWNED ASSAULT RIFLE.

AT AROUND 1400 HRS THE GARAGE DOOR OPENED AT THE RESIDENCE. A WHITE MALE WHO I LATER IDENTIFIED AS KRISTOPHER EXITED THE GARAGE WITH A SMALL GARBAGE CAN. HE EMPTIED THE SMALL GARBAGE CAN INTO THE LARGE BIN LOCATED ON THE SOUTH SIDE OF THE RESIDENCE. KRISTOPHER WAS WEARING TAN COLORED CARGO PANTS AND A BLACK SHIRT. OVER THE BLACK SHIRT WAS A TAN COLORED SHORT-SLEEVE SHIRT THAT APPEARED TO BE A BUTTON-UP SHIRT. HE WENT BACK INTO THE GARAGE AND APPEARED TO BE MOVING ITEMS AROUND AT THE WEST END OF THE GARAGE. I OBSERVED THE GARAGE DOOR CLOSE. IT APPEARED TO ME THAT HE USED A REMOTE DEVICE TO CLOSE THE GARAGE DOOR. HE THEN LEFT THE AREA WESTBOUND ON THE MOTORCYCLE, AT WHICH TIME I GOT A GOOD LOOK AT HIS FACE AND IDENTIFIED HIM AS KRISTOPHER LAUCHNER. I HAD VIEWED HIS KNOWN PHOTOGRAPH.

I ASSISTED DETECTIVES IN FOLLOWING KRISTOPHER TO THE CABELA'S LOCATED NEAR 93 AV AND GLENDALE. I EXITED MY VEHICLE AND WALKED TOWARD THE FRONT OF THE CABELA'S, AT WHICH TIME I OBSERVED KRISTOPHER LOOKING AT SOME SHIRTS AND CLOTHING ITEMS THAT WERE DISPLAYED FOR SALE JUST OUTSIDE OF THE FRONT ENTRANCE.

THINKING THAT KRISTOPHER MAY HAVE RETURNED TO THE CABELA'S TO STEAL ANOTHER RIFLE, I ENTERED THE STORE AND TOOK UP AN ELEVATED POSITION WHERE I COULD WATCH THE PRE-OWNED RIFLES THAT WERE DISPLAYED FOR SALE ON RACKS WITHIN THE STORE. APPROXIMATELY FIVE TO TEN MINUTES LATER I OBSERVED KRISTOPHER IN THIS AREA. I OBSERVED KRISTOPHER PICK UP TWO LONG GUNS IN THIS AREA. I COULD TELL THAT THE FIRST GUN THAT HE PICKED UP WAS SOME TYPE OF DARK COLORED ASSAULT RIFLE. HE REMOVED THIS ITEM FROM ONE OF THE SMALLER RACKS LOCATED TOWARD THE NORTH OF THIS AREA WHERE PRE-OWNED LONG GUNS ARE DISPLAYED. I REVIEWED THE VIDEO WITH RONALD. IN THE AREA OF THE CABELA'S WHERE FIREARMS ARE DISPLAYED FOR SALE, THERE IS A LONG GLASS DISPLAY CASE ON THE NORTH SIDE OF THE STORE WHERE HANDGUNS ARE DISPLAYED. THE DISPLAY CASE RUNS EAST-WEST. TOWARD THE EAST SIDE OF THE CASE, JUST TO THE SOUTH, ARE A FEW SMALL RACKS WHERE LONG GUNS ARE DISPLAYED. THERE ARE ALSO LONGER RACKS IN THIS AREA THAT RUN NORTH-SOUTH. FROM ONE OF THE SMALLER RACKS, KRISTOPHER HAD HANDLED A SMITH AND WESSON .22 LR ASSAULT RIFLE (AR-15 STYLE) DISPLAYING SERIAL NUMBER FROM THE LONGER RACK, KRISTOPHER HAD HANDLED A HI-POINT .45 ACP ASSAULT RIFLE DISPLAYING SERIAL SIMILAR TO WHAT IS SEEN ON PUMP ACTION SHOTGUNS. THIS WAS VISIBLE IN THE VIDEO THAT I HAD VIEWED. NONE OF THE OTHER LONG GUNS IN THIS AREA HAD THIS TYPE OF THICK FOREGRIP.

KRISTOPHER PROCEEDED TO PAY FOR THE COT BY USING A CREDIT CARD IN THE NAME KRISTOPHER LAUCHNER. AFTER PURCHASING THE COT KRISTOPHER WALKED DIRECTLY TO THE MEN'S ROOM WHICH IS LOCATED JUST INSIDE THE ENTRY/EXIT DOOR OF THE CABELAS. DURING THE INVESTIGATION LOSS PREVENTION STAFF LOCATED KRISTOPHER ON VIDEO SELECTING THE RIFLE FROM THE DISPLAY RACK. KRISTOPHER WAS IDENTIFIED AFTER OFFICER MYRMEL COMPLETED A RECORDS CHECK ON THE NAME LISTED FOR THE CREDIT CARD PURCHASE OF THE COT. KRISTOPHER LAUCHNER WAS IDENTIFIED AS THE PERSON IN THE VIDEO BY OFFICER MYRMEL AND A LOSS PREVENTION EMPLOYEE VR1 RONALD BEYE, WHO VIEWED SURVEILLANCE VIDEO OF THE INCIDENT. ON A LATER DATE I SPOKE TO RONALD WHO CONFIRMED HE HAD LOOKED AT A PHOTOGRAPH OF KRISTOPHER FROM THE DEPARTMENT OF CORRECTIONS. FOLLOWING MY CONVERSATION WITH OFFICER MYRMEL WE RESPONDED TO
IN AN ATTEMPT TO LOCATE AND ARREST KRISTOPHER. WHEN
WE ARRIVED AT THE RESIDENCE DETECTIVE M LOWE #12419 LOCATED A
MOTORCYCLE IN THE FRONT YARD OF THE RESIDENCE WHICH WAS LATER

I OBTAINED A DNA SWAB FROM THE TRIGGER AND GRIPS AT 0947 HOURS. THE DNA SWAB WAS LATER IMPOUNDED ON TUESDAY OCTOBER 9TH, 2012 INTO THE GLENDALE POLICE PROPERTY DEPARTMENT AS ITEM NO. 500.

AT THIS TIME, DUE TO THE DAMAGED SERIAL NUMBER PLATE LOCATED ON THE SIDE OF THE RIFLE, I BEGAN SERIAL NUMBER RESTORATION. UPON EXAMINING THE SERIAL NUMBER PLATE, IT APPEARED TO BE OF ALUMINUM METAL. I THEN SANDED THE PLATE, REMOVING THE LAYER OF WHAT APPEARED TO BE BLACK PAINT. RESTOR-A-GEL REAGENT RAG2001 ALUMINUM WAS APPLIED TO THE SERIAL NUMBER PLATE AT INTERVALS OVER A SEVERAL DAY IN AN ATTEMPT TO RESTORE THE DAMAGED SERIAL NUMBER ON THE RIFLE. THE NUMBER '7' DID APPEAR IN THE LATTER END OF THE PLATE. IN EFFORTS TO DEVELOP ADDITIONAL NUMBERS THIS NUMBER WAS LOST.

I INFORMED DETECTIVE M. LOWE REGARDING THIS NEW INFORMATION. HE DID STATE THAT THE SERIAL NUMBER CABELA'S SPORTING GOODS HAD ON FILE FOR THIS RIFLE ALSO HAD A NUMBER '7' IN ITS SERIAL NUMBER.

FURTHER ATTEMPTS WERE MADE TO RESTORE THE SERIAL NUMBER BY USING AN ETCHING SOLUTION FOR ALUMINUM. A CLAY DAM WAS BUILT AROUND THE PLATE, A LIQUID SOLUTION FOR ALUMINUM WAS APPLIED THEN ELECTRICALLY CHARGED. NO ADDITIONAL NUMBERS WERE DEVELOPED.

ON TUESDAY OCTOBER 9TH, 2012 THE RIFLE WAS RETURNED TO DETECTIVE M. LOWE.
